



House rules Hotel Frans op den Bult

Hotel Frans op den Bult has established some house rules that must be followed within the hotel premises. By entering this establishment, you agree to abide by the house rules of Frans op den Bult as outlined below:

1. Smoking in the rooms is strictly prohibited.
2. We promote respectful behavior, and therefore, it is forbidden to use offensive language or make discriminatory remarks.
3. In case of a fire, remain calm. Notify the reception and/or activate the nearest fire alarm.
4. In the event of a general fire alarm, evacuate the premises immediately.
5. Under no circumstances should you use the elevators during a fire.
6. A valid identification must be presented at check-in. Check-in is available for individuals aged 18 and above.
7. The management, owner, or hotel staff cannot be held liable for any injuries, material, or immaterial damages incurred by visitors at the location.
8. Frans op den Bult is not responsible for the loss or theft of your belongings.
9. During your stay, you are using the property of Hotel Frans op den Bult, and it is strictly forbidden to engage in theft or vandalism.
10. To maintain peace, order, and safety within Hotel Frans op den Bult, the use of violence or threats of violence is prohibited.
11. To ensure a pleasant stay, possession, use, or trading of drugs or weapons is strictly prohibited.
12. Rooms and public spaces may not be used for commercial purposes.
13. Hotel Frans op den Bult staff are responsible for your safety, and in case of emergencies, the emergency plan will be implemented. Please follow any instructions from the staff.
14. Do not leave your belongings unattended in your car on the Hotel Frans op den Bult premises. The hotel is not liable for loss, damage, or theft of your property. Parking, both on the hotel premises and in the vicinity of Hotel Frans op den Bult, is at your own risk. Please park your car in designated parking spaces.
15. Hotel Frans op den Bult keeps lost items for a period of 1 month. Found items should be handed in at the reception.
16. To maintain peace in the immediate vicinity of Hotel Frans op den Bult, causing noise disturbances is not allowed.
17. Hosting unregistered or other hotel guests in your room is not permitted. If other guests are found in your room, a suitable fine will be applied.
18. Cameras are located in various places within the building. Anyone inside our hotel consents to the recording of footage. These recordings may be shown to third parties in case of emergencies or incidents.
19. The use of emergency exits as normal entrances and exits is prohibited.
20. Taking hotel property outside the building is prohibited. Deliberate damage to Frans op den Bult property may result in liability for repair and/or replacement costs.
21. Causing disturbances to others, including loud music, disruptive behavior, or any form of noise, is not allowed.
22. Hosting paid guests in your room for sexual activities is prohibited.
