

# House rules Hotel



Hotel Frans op den Bult has established a set of house rules that must be complied within the hotel. When entering the building, the house rules of Frans of den Bult apply and you agree with these house rules drawn up as below.

- 1.** Smoking is prohibited throughout the entire hotel premises.  
*If your room has a balcony, smoking is allowed on the balcony.*
- 2.** We conduct ourselves with respect towards one another; therefore, it is forbidden to express insults or make discriminatory comments.
- 3.** In the event of a fire, remain calm. Report the fire to the reception and / or activate the nearest fire alarm.
- 4.** Immediately evacuate the premises in case of a general fire alarm.
- 5.** Under no circumstances should the elevators be used during a fire.
- 6.** A valid identification document must be presented upon check-in. Check-in is available for individuals aged 18 and above.
- 7.** The management, the owner of the location and/or persons working for the hotel cannot be held liable for any injury and/or material or non material damage that visitors to the location might experience.
- 8.** Frans op den Bult is not responsible for the loss or theft of your belongings.
- 9.** During your stay, you use property of hotel Frans of den Bult , it is forbidden to commit theft or vandalism.
- 10.** To maintain peace, order and safety within the hotel Frans op den Bult, it is forbidden to threaten with or use violence.
- 11.** In order to provide a pleasant stay, possession, use, or trade drugs or weapons is prohibited.
- 12.** Rooms and public areas may not be used for commercial purposes.
- 13.** The staff of hotel Frans op den Bult will monitor your safety and in event of an emergency, the emergency plan will be activated. You are kindly requested to follow any instructions from the employees.
- 14.** Do not leave your belongings unattended in your car at the location of hotel Frans op den Bult. Hotel Frans op den Bult is not liable for the loss, damage or theft of your belongings. Parking, both in the parking lot and in the vicinity of hotel Frans op den Bult, is at your own risk. You must also park your car in the designated parking spaces.
- 15.** Hotel Frans op den Bult retains items for a period of 1 month. Found items must be handed in at the reception.
- 16.** To maintain peace in the immediate vicinity of hotel Frans op den Bult, causing noise disturbances is not allowed.
- 17.** Unregistered guests are not allowed to be received in the room. If other guests are found in the room, an appropriate fine will be charged. If other guests are found in the room, you will be denied access to the hotel without a refund.
- 18.** Cameras are installed in various locations within the building. By entering our hotel premises, individuals consent to being recorded. In case of emergencies and/or incidents, these recordings may be shown to third parties as supporting material.
- 19.** It is prohibited to use emergency exits as normal entrances and exits.
- 20.** Taking hotel property outside the building is prohibited. Individuals who wilfully damaging property of Frans of den Bult can be held responsible for the repair and/or renovation costs.
- 21.** Causing disturbance to others, including through loud music, improper behaviour or any form of noise, is prohibited.
- 22.** Hosting guests in the room for paid sexual activities is prohibited.
